## Aurora Ragdolls - Kitten Contract & Health Guarantee

### Health Guarantee

#### 1. Genetic Health Guarantee (2 Years)

If the kitten dies within two (2) years of the date of birth due to an inherited genetic condition, Purchaser must notify Seller in writing and provide a necropsy report from a licensed veterinarian confirming the cause. If confirmed, Seller will provide a replacement kitten of equal or lesser value, selected by the Purchaser from the next available litter.

- No cash refunds, partial refunds, or credits will be given.
- Shipping and medical expenses are the responsibility of the Purchaser.

#### 2. General Health Guarantee (72 Hours)

This kitten is guaranteed for 72 hours after delivery against the following conditions:

- Upper respiratory infection
- Internal or external parasites
- FeLV (Feline Leukemia) / FIV (Feline Immunodeficiency Virus)

The purchaser agrees to have the kitten examined by a licensed veterinarian within 72 hours of pickup/delivery. If any health concerns are discovered, Purchaser must submit written documentation from the veterinarian within seven (7) calendar days of the exam.

- The kitten may be returned for a replacement only; no refunds will be provided.
  - All veterinary and travel expenses are the responsibility of the Purchaser.

## Ongoing Care Requirements

### Indoor-Only Policy

This kitten must be kept indoors and never allowed to roam freely outside. Outdoor exposure voids all health guarantees.

### Declawing Prohibited

The kitten is never to be declawed. This practice is considered inhumane and will void all health guarantees if performed.

### Nutrition Requirement

To maintain the health guarantee, the kitten must be exclusively fed *Life's Abundance* cat food from this link: [\*Life's Abundance\*](#). This is the food used in our cattery and has been carefully selected to support long-term feline health.

### Veterinary Care & Communication

The purchaser agrees to provide proper nutrition, routine veterinary care, and a safe, loving environment. We ask to be informed of any health concerns that arise during the life of the cat. We are always happy to help and offer guidance where possible.

## Vaccination Protocol

Ragdolls are a more sensitive breed, so we recommend a minimal and cautious approach to vaccinations to prevent immune stress and adverse reactions.

### Our Recommended Protocol:

- **FVRCP Only:** Use only the 3-way FVRCP vaccine (Feline Viral Rhinotracheitis, Calicivirus, Panleukopenia).
- **No 4-Way or Additional Vaccines:** Do not give FeLV, Chlamydia, Coronavirus, Bordetella, or FIP vaccines. These are not recommended and may cause adverse reactions.  
*\* If any of these vaccines are administered, the health guarantee will be considered null and void.*
- **No Boosters Needed:** After the initial FVRCP series and one rabies vaccine, no additional boosters are recommended for the life of the cat.

## **Payment Terms**

### **Reservation Deposit**

A non-refundable \$500 deposit is required to reserve a specific kitten. This deposit is applied toward the total purchase price of the kitten and secures the Purchaser's place until final payment is made.

### **Final Payment**

The remaining balance is due by ten (10) weeks of age. An invoice with full details will be issued to the Purchaser when the balance becomes due.

Failure to submit final payment by the required time frame may result in forfeiture of the reservation deposit and the kitten being made available to another family, at Seller's discretion.

### **Late Pickup & Extended Care Fee**

All kittens must be picked up or delivery arrangements completed no later than fourteen (14) weeks of age, unless otherwise agreed to in writing by Seller.

If a kitten remains in Seller's care beyond fourteen (14) weeks of age due to Purchaser delay or scheduling issues, an extended care fee of \$25 per day will apply, beginning at fifteen (15) weeks of age. This fee covers continued housing, nutrition, litter, socialization, and daily care.

Extended care is not guaranteed and is subject to Seller availability. Failure to arrange pickup or pay applicable extended care fees may result in forfeiture of the reservation and any payments made, at Seller's discretion.

### **Agreement**

This agreement represents the entire understanding between Seller and Purchaser. It is legally binding and governed by the laws of the State of Tennessee.

By completing the purchase, the Purchaser acknowledges they have read, understood, and agree to all terms outlined in this agreement. Digital confirmation at time of sale constitutes acceptance.
